



- Le traitement de remplacement d'opiacé
 - Methadone 1970s 70%
 - Buprenorphine 2001 30%
 - GP&pharmacy 70%, Specialist clinics 30%
- Grossesse et toxicomanie services
 - Since 1980s
- Buprenorphine and grossesse
 - Registered 2001
 - Pregnancy contraindication
 - National clinical guidelines
 - permitted use of buprenorphine in pregnancy from 2003-



Burns 2006: Data linkage Number of women on the NSW Methadone program by year and number of births (1992 to 2002)








Early vs late entry during pregnancy

- 3 groups: méthadone première, méthadone dernière, complétée méthadone (1 année)
- méthadone dernière: more likely
 - Younger, smoke >10/day, Indigenous
 - Late 1st antenatal visit
 OR 2.3 (1.7-3.2)
 - Prematurity OR 2.6 (1.5-3.2)
- Highlights need for early ANC for opiate substitution & pregnancy treatment
- Value of method in demonstrating how 'system is working'





Methadone and child deaths

- 2005: 3/117 morts enfantes méthadone
 - Involved take away methadone
 - Methadone had been administered by an adult
 - Poor communication between treatment agencies and child protection
 - Lack of assessment of stability of parents on methadone
- Possible outcome
 - Removal of all methadone take away doses





Role of buprenorphine?

- No child death recorded worldwide
 - ~500 poisonings
- May be more suitable for parents with children where there are risks to children
- Should these groups be treated with buprenorphine as a first line treatment?
 - Parents
 - Pregnant women





The "winnable war against drugs"

- Aust Govt Committee on Family & Human Services report September 2007
- Recommends:
 - Adoption for children whose parents use *any* illicit drugs
 - Quarantining of welfare payments
 - Change goal of opiate substitution to be 'drug free'
 - Only fund agencies whose goal is abstinence
 - Use of naltrexone implants (not registered)
 - No further response yet... HUNTER NEW ENGLAND
